If a Commandery would like to involve a live candidate(s) and confer an Order as their work to be marked, no dispensation will be necessary.

Dinner: Head tables will be required. The Eminent Commander should collaborate with the Deputy Grand Warder to assure the head table is arranged properly.

## Guidelines for Inspection of the Work to be Marked Grand Commandery of Massachusetts and Rhode Island 2022-2023 Templar Year

- Each Commandery will perform and be marked on the work of any of the three Orders
  - Commanderies are encouraged to perform the work on and for candidates
  - $\circ$   $\,$  Joint performances with no more than two Commanderies are encouraged
  - Dispensation must be submitted as soon as possible if doing jointly
  - This year we will focus on the candidates: the Inspection of the Work will be performed separately from the Reception of the Division Commander, on a regularly scheduled Conclave night, and you are encouraged to work candidates. We spend a great deal of time preparing for this work on which we are marked, so please take advantage of the opportunity to have candidates be part of this earnest effort.
  - For work being done on live candidates, the entire Order will be performed. For the Order of the Temple, the following portions will not be marked: Chamber of Reflection, Hermit Pilgrimage, Years of Warfare, Sepulcher Scene
  - If a Commandery wishes to perform the work alone, please contact your Division Commander.
  - The Inspection of the Work to be marked must take place after November 1, 2022, and before April 30, 2023
  - All Commanderies must submit dates for the Inspection of the Work to be marked to the Grand Inspector Instructor before November 30, 2022
  - Dress rehearsal: Should be scheduled at least one week in advance of the Inspection

## Guidelines for the Public Reception of the Division Commander Grand Commandery of Massachusetts and Rhode Island 2022-2023 Templar Year

- Reception of the Division Commander will not be marked and will be done jointly as a Division.

  - All Commanderies must submit dates for the Reception of the Division Commander to the Grand Inspector Instructor before November 30, 2023
  - Dress rehearsal should be scheduled at least one week prior to the event
  - Inspection of Commandery Charter, By-Laws, records and current IRS Form 990 must take place no later than the date set for the reception of the Division Commander
